Pursuant to Clause 30 of the Listing Agreement, this is to inform you that at the meeting of the Board of Directors of the company held on 30th March, 2015 the following decisions were taken:

- Mrs. Vemuri Shilpa (DIN No. 07140155) is appointed as an Independent Women Director on the Board of the company with effect from 30th March, 2015.
- 2. The Registered Office of the company is shifted from 185,186, Yellampet, Medchal Mandal, R.R. District 501401 to a new leased premises situated at D.No. 1-1-490, Plot No.63, Road No.4, Mohan Nagar, R. R. District -500035, Hyderabad, Telangana with immediate effect. The company is in the process of obtaining 3rd Party, Loan Licence Manufacturing Licences and Drugs Whole Sale Licence and the Production is expected to commence shortly from the new identified Facilities.
