Sub: Disclosure as per Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (“SEBI Listing Regulations, 2015”) – Regarding order from Securities Appellate Tribunal (SAT).

Ref:

- a) **Corporate Announcement under Regulation 30 (LODR)- Intimation about the Order issued by SEBI against the Company and its Directors on 12th August, 2025 and**
- b) **Outcome of Board meeting dated 14th August, 2025.**

Pursuant to the provisions of Regulation 30 of the SEBI Listing Regulations, 2015, and in reference to our earlier disclosures made on the stock exchange on 12th August, 2025 and 14th August, 2025 we hereby submit that, as decided by the Board of Directors in their Board meeting held on 14th August, 2025, Mr. Janakiram Ajjarapu, Non-Executive Director and Promoter of the Company, Mr Sushant Mohan Lal, Director of the company and the Company ie; Decipher Labs Ltd had collectively filed for an appeal with the Securities Appellate Tribunal (“SAT”).

The hearing for appeal against SEBI Order vide QJA/SS/IVD-2/ID18/31578/2025-26 dated 31st July, 2025 was held on 16th September, 2025. The appeal was admitted and the order as received, by our counsel and forwarded after office hours on the 18th September, 2025, is reproduced below:

- a) There shall be no coercive action to recover the disgorgement and penalty amount from Appellants Nos. 1 and 2 (i.e. Mr. Janakiram Ajjarapu and Mr. Sushant Mohan Lal) subject to deposit 50% of the amount within four weeks from the date of order i.e. 16th September, 2025;
- b) Appellants Nos. 1 and 2 (i.e. Mr. Janakiram Ajjarapu and Mr. Sushant Mohan Lal) shall be permitted to sell their shares in their demat account to comply with the order from SAT against Appeal No. 421 of 2025 dated 16th September, 2025 and
- c) Stay is granted on Paragraph No. 105(a) of the impugned order of SEBI Order vide QJA/SS/IVD-2/ID18/31578/2025-26 dated 31st July, 2025 which restricted the Company, namely Decipher Labs Ltd. from buying, selling or otherwise dealing in securities (including units of mutual funds), directly or indirectly for period of one year.

The details as required pursuant to Regulation 30 read with Para A of Part A of Schedule III of SEBI Listing Regulations, 2015, as amended from time to time, read with SEBI Circular No. SEBI/HO/CFD/PoD2/CIR/P/0155 dated 11th November, 2024 and SEBI Circular No. SEBI/HO/CFD/CFD-PoD-2/CIR/P/2024/185 dated 31st December, 2024 (the “SEBI Circulars”) are enclosed herewith as “Annexure A”.
